About the Product

- **Primary Coverages:** CPPL provides coverage against environmental liabilities not typically covered by commercial general liability policies, including defense, indemnity and clean-up cost coverage for unintentional acts, errors or omissions in professional or contracting services resulting in damages, including bodily injury/property damage from pollution and/or indoor contamination
- **Additional Coverages:** Defendants reimbursement, disciplinary proceedings and reputation management, automatic additional insured if required by a written contract, automatic waiver of subrogation if required by a written contract, and softened hammer clause

Key Benefits

- **Excess Liability:** Offered on a supported and unsupported basis
- **Minimum Deductible:** \$2,500.
- **Minimum Premium:** \$1,500.
- **Limits of Liability:** Up to \$5,000,000 each occurrence/\$5,000,000 in the aggregate (primary or excess)
- **Submission Requirement:** 3 years PL/Pollution & GL loss runs
