About the Product

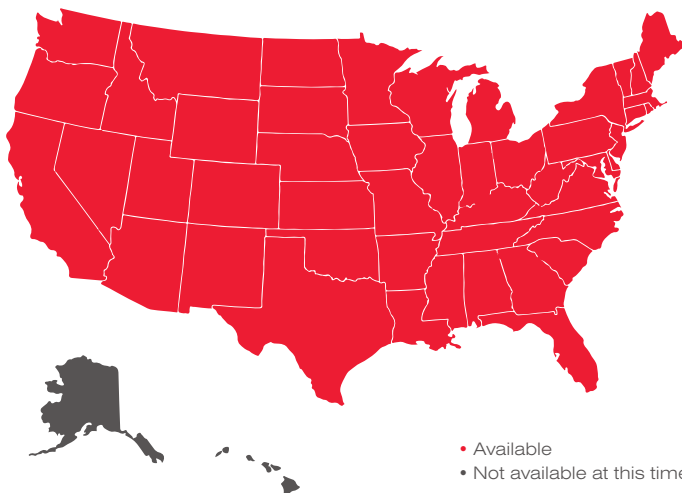
- Business Owner's Policy (BOP) combines business liability and business property insurance into one policy helping protect businesses' property, people and operations, from bodily injury or property damage.
- May include business interruption coverage, including business income and additional expenses, in addition to claims resulting from fire, storms, theft, and other covered events.
- New ventures available for some classes.

Requirements

- Annual revenue: max \$10M general
- Annual payroll: max \$6M general
- GL limits: 300k/600k, 500k/1M, 1M/2M, 2M/4M
- Property TIV: max \$10M/location, \$20M policy limit
- Building less than 6 stories, and 100,000sf
